

Amendment by Université Claude Bernard Lyon 1 to the doctoral charter

The purpose of this amendment is to add to the doctoral charter, particularly in terms of funding, for doctoral students enrolled at Université Claude Bernard Lyon 1.

1. THESIS FUNDING

All students enrolled in a doctoral thesis at Université Claude Bernard Lyon 1 must provide proof of funding to enable them to carry out their research work. The doctoral student's method of funding must be specifically mentioned in the memorandum of understanding. If it comes, even in part, from another paid activity, it must be possible to establish a link with the doctoral student's research work.

In any event, the terms and conditions of this funding must ensure living and working conditions compatible with the requirements of doctoral training. The minimum funding requested by UCBL will correspond to the minimum salary for contract doctoral students, as set by order under Decree no. 2016-1173 of 29 August 2016, which amends Decree no. 209-464 of 23 April 2009.

It is the responsibility of the thesis director, the director of the host laboratory and the director of the doctoral school to ensure that this minimum threshold is reached. In particular, if the doctoral student's funding body defaults during the course of the thesis, the thesis director, the director of the research unit and the director of the doctoral school undertake to seek palliative solutions.

2. THESIS SUBJECT

The subject of the thesis must be linked to a research project that specifies in particular

- the current state of knowledge in the field concerned,
- the place of the project in the host unit's or team's thematic area,
- the scientific objectives and the various stages of the project,
- the resources and methods to be implemented and any external cooperation to be envisaged,
- the educational training possibilities for the doctoral student.

3. RIGHTS AND DUTIES OF THE DOCTORAL STUDENT

The doctoral student will be trained to communicate and discuss his/her results, in particular through regular presentations to his/her research team or research unit, and as far as possible, through one or more presentations at national or international conferences.

Doctoral students are subject to the internal regulations of their host unit, their doctoral school and the Université Claude Bernard Lyon 1. They have access to the University's premises and services and to social works in accordance with their status. They receive the same medical attention as the other members of their unit and/or through preventive medicine.

The doctoral student's research work is carefully recorded in a laboratory notebook that complies with chronological tracking and confidentiality standards. This laboratory notebook remains the property of the host laboratory and may be produced to authenticate a discovery and ensure that the research is promoted. In addition to the laboratory notebook, the doctoral student undertakes to leave all documents, samples, data and results relating to his/her research work with the host laboratory..

He/she undertakes to respect a time limit and a work rhythm. They must inform their thesis supervisor and any co-supervisors of any difficulties encountered and of the progress of their thesis.

Signature protocol: The signatories declare that they are aware of the Doctoral Charter and the amendment specific to Université Claude Bernard Lyon 1.
